



Dog Boarding and/or Day Care - Waiver & Consent

This agreement shall apply to all boarding/day care visits by your dog(s) to MAPLE LAWN BED & BISCUIT, LLC, a New York limited liability company (*Maple Lawn*):

I represent that:

- I am the rightful owner or caretaker of the of the dog(s) described on the application, and I am fully authorized to enter into this Agreement. (____)
- I represent that my dog(s) is in good health, is currently on all required vaccination for Distemper, Rabies, Parvo and Bordetella, has had a negative fecal exam within 6 months of delivery to Maple Lawn for boarding/day care and is free of fleas, ticks, worms, insects or other parasites and has not been ill or exposed to rabies within the last 30 days. (____)
- I understand that while my dog(s) is fully vaccinated, that vaccines are not guaranteed and there is a small risk that my dog(s) may contact a contagious disease or illness. I agree that should this occur, I am responsible for my own pet's care, medical attention and costs.(____)
- My dog(s) has not harmed or shown threatening behaviors towards any person or other dog. (____)
- I understand that although all dogs are fully supervised, incidents of injuries may occur from playing with other dogs, which includes but not limited to bites, scrapes, scratches and sprains. (____)
- I shall continue to disclose on an on-going basis, any and all medical or other conditions, including but not limited to personality concerns or behaviors that may affect, limit or prevent my dog(s) ability to attend the Maple Lawn's facilities. (____)

I agree that Maple Lawn has all rights to refuse to provide pet care services or require my dog(s) to leave Maple Lawn's premises for any reason in their sole and absolute discretion. (____)

I understand that when I deliver my dog(s) to Maple Lawn I am required to provide my dog(s) food and medications, sufficient to cover the length of my dog(s) stay.. (____)

I release Maple Lawn staff, owners and any representatives shall nor be responsible or liable for any lost, stolen or damaged personal property provided by me or delivered with the dog(s).(____)

I RELEASE MAPLE LAWN AND ITS STAFF, OWNERS AND ANY REPRESENTATIVES FROM ANY AND ALL LIABILITY WHICH I OR MY DOG(S) MAY SUFFER INCLUDING BUT NOT LIMITED TO INJURY, SICKNESS, DAMAGE, OR DEATH RESULTING FROM PARTICIPATION IN DAYCARE AND BOARDING. (____)

Should any injuries or illness to my dog(s) require immediate medical attention, I authorize Maple Lawn to use the veterinary facility it deems most appropriate. I understand that if my veterinarian is conveniently located, Maple Lawn may but shall, in no event, be obligated to use my veterinarian for my dog(s) care. In any case, I authorize Maple Lawn to contact my veterinarian in connection with any medical issues regarding my dog(s). I further agree that I shall be financially responsible for any for any medical expenses incurred on behalf of my dog(s) over thecours of my dog(s) stay with Maple Lawn. (____)

If I or my authorized contact cannot pick up my dog(s) at the agreed pick-up time, I authorize Maple Lawn to provide additional overnight and daycare services at my expense. (____)

I agree that I may not leave my dog(s) at Maple Lawn after the scheduled pick up time without communication from me. I agree that if I leave my dog(s) at Maple Lawn without any contact, instruction or notification regarding its pick up from me, my dog(s) will be deemed "Abandoned" at 7 P.M. on the seventh (7th) day after the scheduled pick up date. I understand a certified letter regarding this abandonment will be sent by Maple Lawn to me the my last address I provided Maple Lawn. I agree that for fourteen (14) days after the mailing of the notice I shall have the right to reclaim the dog(s) upon payment of all reasonable charges, and after the fourteen days I shall be deemed to have waived the rights to the dog(s), and Maple Lawn will become its legal owner and guardian. In such case, Maple Owner will, in its sole discretion, determine whether to re-home the animal(s), relinquish animal(s) to a shelter/rescue or humanely destroy the abandoned animal(s). **I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON THE DOG(S), I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY DOG(S) AND WILL HAVE NO RECOURSE AGAINST MAPLE LAWN.** (____)
